<b>99</b>	<b>Non-corporate Commonwealth entity</b> is a Commonwealth entity that is not a body corporate.*
<b>71</b>	<b>Corporate Commonwealth entity</b> is a Commonwealth entity that is a body corporate.*
<b>18</b>	<b>Commonwealth company</b> is a <i>Corporations Act 2001</i> company that the Commonwealth controls.

KEY TO SYMBOLS	
Governance Structure or Characteristics	
<b>B</b>	Prescribed as Government Business Enterprises under the PGPA Rule.
<b>M</b>	Material entities and companies (comprising 99% of revenues, expenses, assets and liabilities of the total General Government Sector). All Departments of State are considered material in nature.
<b>I</b>	Inter-jurisdictional entities in nature (interacts with State, Territory or foreign governments)
<b>R</b>	Corporate Commonwealth entities established by regulation under an Act and/or by a rule under the PGPA Act.
<b>HC</b>	The Attorney-General's portfolio includes the <a href="#">High Court of Australia</a> , which is part of the Commonwealth, is an "agency" named in the annual Appropriation Acts and is in the "General Government Sector". However, it is not a Commonwealth entity under the <a href="#">PGPA Act</a> , due to its status under its enabling legislation, which also sets its employment framework.
<b>E</b>	Executive Agency, through an Order made by the Governor-General, under subsection 65(1) of the <i>Public Service Act 1999</i>
<b>*</b>	3 entities have a body corporate status but are prescribed as non-corporate Commonwealth entities.
Employment Arrangements	
<b>PS Act</b>	Officials are taken to be employed under <i>Public Service Act 1999</i> unless stipulated by an employment related key below.
<b>^</b>	Entities that do not engage staff under the PS Act.
<b>#</b>	Entities can engage officials under enabling legislation as well as PS Act. These include Defence entities under the <i>Defence Act 1903</i> .
<b>▲</b>	Has officials employed under the <i>Parliamentary Service Act 1999</i> .
Government Finance Statistics (GFS) Classification	
<b>GGGS</b>	All Commonwealth entities and Commonwealth companies are part of the GGS unless stipulated by a GFS classification below.
<b>T</b>	Public Non-financial Corporation (Trading)
<b>F</b>	Public Financial Corporation
Government Requirements	
<b>Ⓢ</b>	Subject to the requirements of the Commonwealth Procurement Rules (CPRs). All non-corporate Commonwealth entities are subject to the CPRs.
<b>X</b>	Entities that are exempt, or partially exempt, from government policy orders (section 22 of the PGPA Act).
Definitions	
<b>Listed Entities</b>	A listed entity is a non-corporate Commonwealth entity prescribed by an Act or the PGPA Rule. All non-corporate Commonwealth entities are "listed entities" except for Departments of State and Parliamentary Departments.
